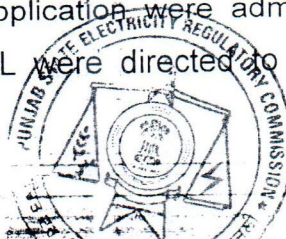

**ORDER**

The petition and Interlocutory Application were admitted vide Order  
dated 11.08.2015. PSPCL and PSTCL were directed to file reply to the



petition and IA by 25.08.2015. PSTCL vide memo No.7435 dated 31.08.2015 has submitted that PSTCL/SLDC does not levy any penalty as mentioned in the petition. However the same is to be levied by PSPCL as per its Commercial Circular No.29 of 2015 and all other difficulties mentioned in the petition also relate to PSPCL. Since no implication financial or otherwise involved PSTCL/SLDC, it has no comments to offer in this case.

PSPCL has prayed vide memo No.5500 dated 31.08.2015 for grant of at least two weeks time for submission of reply to the petition and IA. PSPCL shall file reply to the petition and IA by 15.09.2015 with copy to the petitioner.
