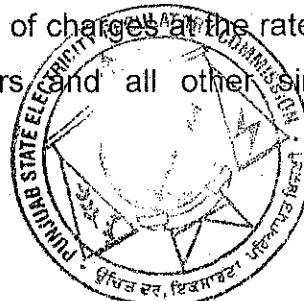




consumers on the power purchased through open access during peak load hours from 6.00 PM to 10.00 PM during the pendency of this petition.
