Subject: - Power Purchase Cost Adjustment Charges (PPAC)

Sir,

The Commission has received applications dated 17.04.2013, 25.04.2013 & 26.04.2013 from TPDDL, BRPL & BYPL regarding Power Purchase Cost Adjustment Charges (PPAC) for the quarter Jan, 13-March, 13(Q4) in compliance with the order of the Commission dated 13.07.2012. BRPL, BYPL & TPDDL have sought an increase of 9.2%, 9.13%, & 1.71% respectively on account of Power Purchase Cost Adjustment Charges for Quarter-4.

2. Further, BRPL & BYPL vide their letters dated 25.04.2013 & 26.04.2013 respectively have also requested to allow the balance claim of PPA of 19.5% & 12.43% against Quarter-2 & Quarter-3 as well whereas, TPDDL vide aforesaid letter dated 17.04.2013 has requested to approve the claim of 12.47% against Quarter-2 to Quarter-4.

3. Preliminary scrutiny of the claims of BRPL, BYPL & TPDDL reveals that the claims of PPAC have been made including the bills relating to supplementary & past arrears. The Commission has decided not to consider the supplementary bills and those relating to past arrears. Such an approach had been adopted in earlier Quarters this year as well as for evaluating the Fuel Price Adjustment Charges (FPAC) in prior periods.

4. On the basis of the information submitted by the Discoms and also considering the fact that, power from low cost stations have been regulated in case of BRPL & BYPL, the Commission approves the following Power Purchase Cost Adjustment Surcharge on a provisional basis for the period 01.05.2013 to 31.07.2013 or till further order whichever is earlier :-

BRPL	4.50%
BYPL	4.50%
TPDDL	3.00%

5. It is clarified that Power Purchase Cost Adjustment Charges is a component of tariff and its application shall be in the same manner as in the case of a tariff revision i.e. it shall be applicable only on the pro-rata consumption with effect from 01.05.2013. Further, it is clarified that the above PPAC is to be levied only on the basis of energy consumed from 01.05.2013 onwards for a period of 3 months upto 31.07.2013. The consumption shall be determined on a pro-rata basis if meter reading includes the consumption of the period before 01.05.2013 or after 31.07.2013.

6. It is also clarified that :-

- (a) The PPAC surcharge of 4.5% for BRPL & BYPL and 3% for TPDDL respectively replaces the earlier PPAC surcharge of 3% for BRPL & BYPL and 1.5% for TPDDL which was valid till 30.04.2013.
- (b) The percentage increase on account of PPAC will be applied as a surcharge on the total energy and fixed charges (excluding arrears, LPSC, E-Tax etc.) billed to a consumer of the utility.
- (c) The bill format shall clearly identify the PPAC percentage and amount of PPAC surcharge billed as separate entries.
- (d) The distribution licensee should levy PPAC after considering rebate on energy charges, if any, available to the consumer.
- (e) PPAC surcharge should not be levied on the 8% surcharge and also the 8% additional surcharge towards recovery of past accumulated deficit is not to be levied on PPAC.

This issues with the approval of the Commission.
